## **REGULAR MEETING UNION PARISH POLICE JURY**

Farmerville, Louisiana July 6<sup>th</sup>, 2021

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan, Brenda Abercrombie and John W. Watley. Absent: Nathan Pilgreen. Also present was Tracy Houck, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Nolan offered the invocation. Mr. Ramsey led the group in the Pledge of Allegiance to the Flag.

President Buckley welcomed everyone to the meeting and asked if anyone in the audience would like to register for public comment. At this time the public was given the opportunity to comment on any item shown on the agenda.

Motion Mr. Bridges, seconded by Mr. Watley and declared adopted by unanimous vote of the Jury to approve the agenda as written.

Motion Mr. Ramsey, seconded by Mr. Moses to adopt the minutes of the June 1<sup>st</sup>, 2021 regular meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report for the month of June and explained to the jurors that the report reflects what has been budgeted for the year compared to what has been spent. Each juror received a copy of the Revenue and Expense Report in their email packet. The Secretary/Treasurer reported that at this point in the year approximately 50% of the budget should have been expended.

On June 1<sup>st</sup> the jury received a payment of \$2,147,110 for the American Rescue Plan. The jury will receive an equal amount in 2022. The total amount will be \$4,294,220. The American Rescue Plan is basically a continuation of the CARES Act Program. The money the jury received for the American Rescue Plan went into a separate account and will not be comingled with any other money.

There are four broad categories listed and according to the American Rescue Plan website recipients have broad flexibility to decide how to best use the funding to meet the needs of their communities. Funds can be used to invest in infrastructure such as water, sewer and broadband; to improve air quality; building of new infrastructure; premium pay for essential workers. Funds can also be used to enhance the technology that is used during public meetings and the broadcasting of such meetings. At this time, funds cannot be used for roads, to payback outstanding debt or to replenish budget shortfalls and pensions.

# Motion Mr. Bridges, seconded by Mr. Nolan to adopt the Revenue and Expenditures Report for the month of June. Motion carried unanimously.

**Pafford Ambulance** – Keith Carter, Chief Operating Officer with Pafford Ambulance, addressed the Jury concerning the recent complaints. Mr. Carter is in agreement with an Ambulance Oversite Committee. Pafford wants to be transparent with its response times and plans moving forward. Mr. Carter stated that there are two (2) twenty-four hour paramedic

ambulances in Farmerville and one (1) twenty-four advanced ALS ambulance in Bernice. Upsurge trucks are brought in on an as-needed basis. Mr. Carter stated that over a two-year period Pafford has responded to all priority one calls and all priority two calls in Union Parish at an average of thirteen (13) minutes and forty-seven (47) seconds per call. Mr. Carter further stated that when COVID hit in April of 2020 all transporting basically shut down. It picked back up in June of 2020. When COVID hit, Pafford did not have adequate PPE, nor training. Several of Pafford's employees left the company when COVID hit.

North Delta Regional Planning and Development District – Doug Mitchell addressed the jury regarding the property description on Precinct #3. Mr. Mitchell has been in contact with Bill Blair with the House of Representatives. There are a couple of minor errors in the property description of Precinct #3. The errors are small directional errors. These will be technical amendments.

Mr. Mitchell addressed the jury regarding redistricting. The data has been compiled but will not be released until the end of September. Mr. Mitchell said it would benefit the police jury to work with the school board to save costs when redistricting is done. Mr. Mitchell also addressed the jury regarding Broadband Internet.

Motion Mr. Bridges, seconded by Mr. Nolan to approve Precinct 3 correction to read as follows:

### Precinct 3

The point of beginning being the intersection of U.S. Highway 167 South and 3<sup>rd</sup> Street; thence southerly on U.S. Highway 167 Street to 5<sup>th</sup> Street; thence Easterly on 5<sup>th</sup> Street to its intersection with Cedar Street; thence southerly along Cedar Street to its intersection with 8<sup>th</sup> Street; then Westerly on 8<sup>th</sup> Street to its intersection with La. State Hwy. 2; thence westerly along La. State Hwy 2 to its intersection to Van Roach Rd.; thence north along Van Roach Rd. to its intersection with Chip Mill Rd.; thence east along Chip Mill Rd. to its intersection with Busby Rd.; thence northerly along Busby Rd. to its intersection with State Highway 2 Alt. (Summerfield Highway); thence easterly along State Highway 2 Alt. (Summerfield Highway) to its intersection Grafton Xing; thence northerly and easterly to its intersection with Pisgah Church Rd.; thence proceed in a generally southerly direction along Pisgah Church Rd.; thence proceed easterly on Pisgah Church Road to its intersection with Holly St.; thence southerly along Holly St. to its intersection with 3<sup>rd</sup> Street; thence westerly along 3<sup>rd</sup> Street and back to the point of beginning.

The Secretary/Treasurer addressed the jury regarding the six month road and landfill material bids. Three bids were received for the Daily Alternative Cover (Landfill). Two of the three bids received had issues. The bid received from LSC did not meet the requested specs (no unloading of material was provided – bid specified that material must be unloaded) and is therefore being rejected. The bid from Space Savers was received two hours late, but they provided proof where they FedExed the bid on 6/21/21 with a two-day guaranteed delivery. The FedEx receipt has been supplied. Attorney, Trevor Fry with the Gold Weems law firm was consulted. Mr. Fry stated in his email that the purpose of the public bid law is to protect public funds. Space Savers did mail the bid on time and provided proof. Mr. Fry provided an attorney general opinion that had a similar circumstance. Mr. Fry is recommending accepting the bid from Space Savers in addition to Enviro Services. Motion Mrs. Abercrombie, seconded by Mr. Watley, that the following actions should be taken on the road and landfill material bids for the period of July 1, 2021 through December 31, 2021:

- Gasoline and diesel fuel should be awarded to Hill Oil Co. and Daniel Green Oil Co. based upon the best price, availability, hauling, location of job and quantity needed.
- Aviation Fuel No bids were received for Aviation Fuel.
- CRS-2 Asphalt Emulsion No bids were received for CRS-2 Asphalt Emulsion.
- AEP Asphalt Emulsion Prime No bids were received for AEP Asphalt Emulsion Prime.
- MC-30 Cutback Asphalt No bids were received for MC-30 Cutback Asphalt.
- Spiral Metal Culverts Bid should be awarded to Co-Heir Drainage Products (only bidder).
- Polyethylene pipe should be awarded to Co-Heir Drainage Products and Irrigation Mart, Inc. based upon the best price, availability, hauling, location of job and quantity needed.
- Concrete Pipe Bid should be awarded to Co-Heir Drainage Products (only bidder).
- Hot Mix and Cold Mix Bid should be awarded to Dreher Contracting (only bidder).
- Maintenance rock, oversize rock, clay gravel, fill sand, pea gravel, and concrete sand No bids were received for maintenance rock, oversize rock, clay gravel, fill sand, pea gravel, and concrete sand.
- Crushed concrete No bids were received for crushed concrete.
- Granite rock should be awarded to R. E. Bentz, Inc. (only bidder).
- Leachate Collection Sand No bid was received for Leachate Collection Sand.
- Daily alternative cover for landfill should be awarded to Enviro Services, LLC and Space Savers based upon the best price, availability, hauling, location of job and quantity needed. **Bid covers the period of July 1, 2021 June 30, 2021.**

Motion carried unanimously.

Motion Mr. Watley, seconded by Mr. Nyegaard to assist the Town of Bernice in repairing a street shoulder that is caving in on the corner of Cemetery and Walnut Streets. The Town of Bernice will pay for the cost of the materials. This work will be performed as time permits. Motion carried unanimously.

Motion Mr. Moses, seconded by Mr. Nyegaard to allow the Farmerville Jaycees the use of the Courthouse Square and parking lot on Friday July 30<sup>th</sup> and Saturday July 31<sup>st</sup> for the 58<sup>th</sup> Annual Louisiana Watermelon Festival. Motion carried unanimously.
