The Detention Center is continuing to show great improvement. The Transitional Work Release program took a slight hit due to the Louisiana Justice Reinvestment Act 280. The TWP numbers should be back up by the end of January. Mr. Parker and the Detention Center Commission should be commended on their hard work. Motion Mr. Taylor, seconded by Mr. Jones to approve expenses for Pat Bankston, Union Parish Registrar of Voters Office, to attend a workshop on January 31, 2018 to February 2, 2018 in Marksville, Louisiana.

Motion Mr. Hutto, seconded by Mr. Kennedy to approve the application of Wilderness Acres for a beer/liquor license for the year 2018 pending all necessary documents/paperwork are received and authorize the President to execute all necessary documents. Motion carried unanimously.

Motion Mr. Parker, seconded by Mr. Kennedy to approve the Louisiana Compliance Questionnaire for the 2017 audit and authorize the President and Secretary/Treasurer to execute all necessary documents. Motion carried unanimously.

Courthouse Committee:

Motion Mr. Parker, seconded by Mr. Futch to purchase a security system upgrade for the Annex with an approximate price of \$3,950. Motion carried unanimously.

Road Committee:

Motion Mr. Watley, seconded by Mr. Hutto to accept Change Order No. 3 for Various Bridge Repair Projects F.Y. 2016 – Rocky Branch Road Bridge Over Bayou D'Arbonne and authorize the President to execute all necessary documents. Motion carried unanimously.

Motion Mr. Watley, seconded by Mr. Taylor to accept the Certificate of Substantial Completion (partial) for Various Bridge Repair Projects F.Y. 2016 – Rocky Branch Road Bridge Over Bayou D'Arbonne provided the Change Order No. 3 has been signed by Ben Allen and authorize the President to execute all necessary documents. Motion carried unanimously.

Motion Mr. Watley, seconded by Mr. Jones to authorize the Periodic Estimate for Partial Payment No. 6 for Various Bridge Repair Projects F.Y. 2016 – Rocky Branch Road Bridge Over Bayou D'Arbonne provided the Change Order No. 3 has been signed by Ben Allen. Motion carried unanimously.

The following resolution was offered by Mr. Watley and seconded by Mr. Hutto:

RESOLUTION #2017-19

WHEREAS, the Union Parish Police Jury has received a recommendation from the Road Committee after it has reviewed the Road Priorities that have previously been adopted, recommended Road Priorities to adopt and recommended projects to approve for F.Y. 2018, F.Y. 2019, F.Y. 2020 and F.Y. 2021; and

WHEREAS, the Union Parish Police Jury due to declining funds available for capital road projects beginning in F.Y. 2004 funded only collector roads in an effort to address the roads with the highest use; and

WHEREAS, the Union Parish Police Jury due to insufficient funds available for capital road projects beginning in F.Y. 2006, and continuing through F.Y. 2007- F.Y. 2012 adopted a stand still priority list by not naming any additional roads until funding became available; and

WHEREAS, certain road construction funds became available in F.Y. 2013 through F.Y. 2016 and a portion of the previously adopted priorities for capital road projects were addressed with the available funds. The Road Committee has reviewed the status of Road Priorities that have previously been adopted and anticipated to extend through F.Y. 2018; and

WHEREAS, after consulting page 1 and page 2 in Section 3 of the Union Parish Police Jury's Road Ranking Lists for Road Project Prioritization, dated May 24, 2000, and recommended that no additional road priorities be adopted for capital road improvement projects at this time:

Anticipated F.Y.	Road Name/Beginning/Ending
F.Y. 2018	No capital road projects will be funded
F.Y. 2019	Rocky Branch Road from Acree Road to bridge. Bear Creek Drive from Bear Drive to end of pavement. Hopewell Road from LA Hwy 828 to Hudson Road.
F.Y. 2020	Pilgrims Rest Church Road from Spearsville Corp Limits to AR state line.
F.Y. 2021	Roan Road from LA Hwy 143 to John Haye Road. Sweet Lily Road from Salem Road to end of pavement. Tom Dean Road from LA Hwy 549 to Patterson Lake Road.

BE IT RESOLVED by the Union Parish Police Jury that these priorities be confirmed and that the projects are hereby authorized to be done in F.Y. 2019, F.Y. 2020 and F.Y. 2021 subject to a favorable report from the Finance Committee concerning each fiscal year funding availability. **WHEREUPON**, the motion was declared duly adopted by unanimous vote of the Jury this the 19th day of December, 2017.

The Finance Committee met earlier with regards to the proposed 2017 revised budget and the proposed 2018 budget.

Mr. Jones addressed the jury regarding the West Sterlington Sewer District. He has met with the Town of Sterlington and the Town of Sterlington is willing to take over the West Sterlington Sewer at no cost provided a written proposal is submitted to the Board of Aldermen of the Town of Sterlington. The Town of Sterlington is willing to take ownership of the assets of the sewer system and be responsible/liable for its continued operation. Motion Mr. Jones, seconded by Mr. Parker to direct Mr. Hampton to draw up a written proposal for the Town of Sterlington to take ownership of the West Sterlington Sewer System. The proposal will then be submitted to the Board of Aldermen for the Town of Sterlington. Motion carried unanimously.

In accordance with Ordinance 549, time for public comment was given. Mr. Bobby Hodge, 705 Hodge Road, Farmerville addressed the jury concerning Meeks Landing. Mr. Hodge is urging the jury to get a clear judgment and take the fence down.

There being no further business to come before the Jury, the President declared the meeting adjourned upon motion by Mr. Hutto, seconded by Mr. Taylor on this the 19th day of December, 2017.
