REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana December 6th, 2016

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Charles Sawyer, Jerry W. Taylor, Glenn Hutto, Derek S. Kennedy, Nathan Futch, Stan Smith, Mike Jones, Lanny Parker and John Watley. Also present was Bruce Hampton, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Watley offered the invocation and Mr. Jones led the group in the Pledge of Allegiance to the Flag.

President Sawyer asked if anyone in the audience would like to register for public comment. The jury offered it's condolences to the families of Pat Taylor and Miller Booth. The jury would also like to offer its condolences to the family of Alexis Weakley. The public was given the opportunity to comment on any item shown on the agenda. No comment was made.

After the opportunity for public comment was given, a Motion was made by Mr. Hutto, seconded by Mr. Taylor and declared adopted by unanimous roll call vote of the Jury to approve the agenda with four additions:

- 14 Discuss and take action, if necessary, setting the speed limit on Tucker/Pilgreen Road to 35 MPH in its entirety.
- Discuss and take action, if necessary, on the reappointment of Jerry Farrar to the Rocky Branch Waterworks Board of Commissioners for a five year term.
- Discuss and take action, if necessary, awarding bids for sale of surplus property and authorize President to execute all necessary documents.
- Discuss and take action, if necessary, concerning the bids for road materials and supplies for January 1, 2017 June 30, 2017.

Motion Mr. Taylor, seconded by Mr. Jones to adopt the minutes of the November 1st, 2016 regular meeting and November 21st, 2016, special meeting. Motion carried unanimously.

Motion Mr. Kennedy, seconded by Mr. Hutto to adopt the Revenues and Expenditures Report for the month of November 2016. Motion carried unanimously.

Motion Mr. Jones, seconded by Mr. Kennedy that after the Secretary/Treasurer's probationary period is up her salary be set to the amount that was initially agreed

upon provided she satisfactorily completes her probationary period. Motion carried unanimously.

The Finance Committee met earlier concerning the 2017 proposed consolidated budget and the 2016 proposed amended budget. A hearing will be held on December 29, 2016 at 4:30 PM to finalize the budget. No action taken at this time.

Motion Mr. Taylor, seconded by Mr. Parker to renew the worker's compensation insurance plan with The Lincoln Agency, LLC, effective January 1, 2017 and to authorize the president to execute any necessary documents. Motion carried unanimously.

Motion Mr. Kennedy, seconded Mr. Hutto to approve the following applications for beer and liquor licenses for the year 2017 pending all necessary documents/paperwork are received and authorize President to execute all necessary documents. Motion carried unanimously.

ORDINANCE #770

AN ORDINANCE SETTING THE SPEED LIMIT OF 35 MILES PER HOUR ON TUCKER/PILGREEN ROAD IN ITS ENTIRETY AND SETTING PENALTIES FOR VIOLATIONS.

SECTION I: BE IT ORDAINED by the Police Jury of Union Parish that a maximum speed limit for any truck, car, motorcycle or any other equipment traveling on the Tucker/Pilgreen Road, in its entirety, shall not exceed 35 miles per hour.

SECTION II: BE IT FURTHER ORDAINED by the Police Jury of Union Parish, State of Louisiana, that any person, firm or corporation violating any provisions of this ordinance, upon conviction, shall not exceed the maximum fine for speeding upon a state highway plus court cost.

SECTION III: BE IT FURTHER ORDAINED that if any section, sentence, clause or words of this ordinance shall be held invalid by any court of final jurisdiction, the same shall not affect the validity of any other section.

SECTION IV: BE IT FURTHER ORDAINED that ordinance or parts of ordinance in conflict herewith be and the same are hereby repealed.

The foregoing ordinance was introduced by Mr. Taylor, who moved its adoption and duly seconded by Mr. Hutto and was then adopted by the following YEA and NAY vote:
