REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana November 6th, 2018

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Charles Sawyer, Lanny Parker, Jerry W. Taylor, Glenn Hutto, Derek Kennedy, Nathan Futch, Stan Smith, Mike Jones and John Watley. Absent: None. Also present was Michael Mahaffey, Assistant District Attorney. The President called the session to order and welcomed all guests. Wayne Whiteside, Pastor at Crestview Baptist Church offered the invocation and Jimmy Odom, Commander at the local VFW, led the group in the Pledge of Allegiance to the Flag.

President Taylor reminded the members in the audience to silence their cell phones. President Taylor asked if anyone in the audience would like to register for public comment. The public was given the opportunity to comment on any item shown on the agenda.

President Taylor would like to remember the veterans who have served our country. President Taylor would also like to acknowledge Paula Strickland. Mrs. Strickland was recently elected to serve as Treasurer for the North Delta Regional Planning and Development Board. Mr. Sawyer was elected to serve as Member at Large on that same board. President Taylor would also like to remember the family of Velvet Bennett Roberts. Mrs. Roberts recently passed.

After the opportunity for public comment was given, a Motion was made by Mr. Hutto, seconded by Mr. Sawyer and declared adopted by unanimous roll call vote of the Jury to approve the agenda as written.

Motion Mr. Sawyer, seconded by Mr. Watley to adopt the minutes of the October 2nd, 2018 Regular Meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report and explained to the jurors that the report reflects what has been budgeted for the year compared to what has been spent. The jurors were given time to comment on the report. No questions were asked. Motion Mr. Kennedy, seconded by Mr. Parker to adopt the Revenues and Expenditures Report for the month of October 2018. Motion carried unanimously.

Richard Royal addressed the jury on behalf of the Union Parish Chamber of Commerce. The Union Parish Chamber of Commerce is requesting \$2,500 from the police jury for the 2019 National American Crappie Trail Tournament. Motion Mr. Hutto, seconded by Mr. Kennedy to deny the request from the Union Parish Chamber of Commerce. Motion carried unanimously.

Motion Mr. Watley, seconded by Mr. Hutto to approve the annual bridge certification and authorize the President to sign all necessary documents relating to the Annual Certification of Compliance for 2018.

RESOLUTION 2018-08 ANNUAL CERTIFICATION OF COMPLIANCE WITH STATE OF LOUISIANA OFF SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each state; and

WHEREAS, the responsibility to inspect, rate and load post these bridges under the authority of Union Parish in accordance with those Standards is delegated by Louisiana Department of Transportation and Development to Union Parish,

THEREFORE, BE IT RESOLVED by the governing authority of Union Parish that the Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for a period October 1, 2017 through September 30, 2018:

The Parish has performed all interim inspections on all Parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.

All bridges owned and maintained by the Parish have been structurally analyzed and rated by the parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LA DOTD for all bridges where the maximum legal load under Louisiana State law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, any obsolete structural ratings or any missing structural ratings.

All Parish owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standard Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.

All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the LA DOTD are noted.

RESOLUTION #2018-09

WHEREAS, the Union Parish Police Jury has received a recommendation from the Road Committee after it has reviewed the Road Priorities that have previously been adopted, recommended Road Priorities to adopt and recommended projects to approve for F.Y. 2018, F.Y. 2019, F.Y. 2020 and F.Y. 2021; and

WHEREAS, the Union Parish Police Jury due to declining funds available for capital road projects beginning in F.Y. 2004 funded only collector roads in an effort to address the roads with the highest use; and

WHEREAS, the Union Parish Police Jury due to insufficient funds available for capital road projects beginning in F.Y. 2006, and continuing through F.Y. 2007- F.Y. 2012 adopted a stand still priority list by not naming any additional roads until funding became available; and

WHEREAS, certain road construction funds became available in F.Y. 2013 through F.Y. 2016 and a portion of the previously adopted priorities for capital road projects were addressed with the available funds. The Road Committee has reviewed the status of Road Priorities that have previously been adopted and anticipated to extend through F.Y. 2021; and

WHEREAS, after consulting page 1 and page 2 in Section 3 of the Union Parish Police Jury's Road Ranking Lists for Road Project Prioritization, dated May 24, 2000, and recommended that no additional road priorities be adopted for capital road improvement projects at this time:

Anticipated F.Y.	Road Name/Beginning/Ending
F.Y. 2018	No capital road projects will be funded
F.Y. 2019	Rocky Branch Road from Acree Road to bridge. Bear Creek Drive from Bear Drive to end of pavement. Hopewell Road from LA Highway 828 to Hudson Road.
F.Y. 2020	Pilgrims Rest Church Road from Spearsville Corp Limits to AR state line.

F.Y. 2021

Roan Road from LA Highway 143 to John Haye Road. Sweet Lily Road from Salem Road to end of pavement. Tom Dean Road from LA Highway 549 to Patterson Lake Road.

BE IT RESOLVED by the Union Parish Police Jury that these priorities be confirmed and that the projects are hereby authorized to be done in F.Y. 2018, F.Y. 2019, F.Y. 2020 and F.Y. 2021 subject to a favorable report from the Finance Committee concerning each fiscal year funding availability.
