#### REGULAR MEETING UNION PARISH POLICE JURY

### Farmerville, Louisiana May 4th, 2021

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan, Brenda Abercrombie and John W. Watley. Absent: None. Also present was Tracy Houck, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Ramsey offered the invocation. Mr. Watley led the group in the Pledge of Allegiance to the Flag.

President Buckley welcomed everyone to the meeting and asked if anyone in the audience would like to register for public comment. At this time the public was given the opportunity to comment on any item shown on the agenda.

Motion Mr. Nolan, seconded by Mr. Moses and declared adopted by unanimous vote of the Jury to approve the agenda as written.

Motion Mr. Ramsey, seconded by Mr. Watley to adopt the minutes of the April 6<sup>th</sup>, 2021 regular meeting and the April 19<sup>th</sup>, 2021 special meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report for the month of April and explained to the jurors that the report reflects what has been budgeted for the year compared to what has been spent. The Secretary/Treasurer reported that at this point in the year approximately 33% of the budget should have been expended.

The Secretary/Treasurer reported that the John Deere tractor with side mower was delivered to the Road Department today. The tractor will be paid for with LGAP grant funds. The trucks for the Road Department are still on order.

The work release program at the Detention Center generated \$114,522.22 for the month. As of today, May 4<sup>th</sup>, there are currently one hundred inmates participating in the work release program. There are currently 232 DOC inmates and 130 parish inmates being housed at the Detention Center. There is no state income reported on the Revenue and Expense reports due to the state being late with the payment.

The one cent sales tax for the Landfill generated \$283,311.74 in income for the month of April which is a 37% increase over last year at this time. The tipping fees generated \$131,978.04 for the month of April.

Litter court generated \$1,844 in fines and that was paid out to the Constables/JP's who write the tickets. If a constable does not write any tickets then neither he nor his JP any revenue.

Motion Mr. Bridges, seconded by Mr. Ramsey to adopt the Revenue and Expenditures Report for the month of April. Motion carried unanimously.

Motion Mr. Ramsey, seconded by Mr. Nolan to authorize travel for Lane Rugg, Road Superintendent to attend the Police Jury Association conference to be held in Baton Rouge on May 12<sup>th</sup>, 2021 through May 14<sup>th</sup>, 2021. Motion carried unanimously.

Motion Mr. Ramsey, seconded by Mr. Watley to authorize travel for the Assistant Landfill Superintendent, Milas Joe Davidson, to attend the Louisiana Solid Waste Convention to be held in Lafayette on September 15<sup>th</sup>, 2021 through September 17<sup>th</sup>, 2021. Motion carried unanimously.

#### **SECTION 504 GRIEVANCE PROCEDURE**

The Union Parish Police Jury has adopted an internal grievance procedure providing for prompt and equitable resolution of complaints alleging any action prohibited by the regulation of the U.S. Department of Housing and Urban Development, 24 CFR Part 8, implementing Section 504 of the Rehabilitation Act of 1973, as amended (Public Law 93-112). Section 504 states, in part: "No otherwise qualified handicapped individual ... shall, solely by reason of his handicap be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." To further assist those who may have a grievance concerning Section 504 compliance **Paula Strickland** has been designated to coordinate the efforts of the Union Parish Police Jury to comply with requirements of Sec. 504 and its implementing regulation, 24 CFR Part 8.

- 1. A complaint should be in writing, contain the name and address of the person filing it, and briefly describe the action alleged to be prohibited by the regulation.
- 2. A complaint should be filed in the office of the Section 504 Coordinator within a reasonable time after the person filing the complaint became aware of the action alleged to be prohibited by the regulation.
- 3. The Compliance Coordinator shall meet with the complainant within 15 days after receipt of the complaint to discuss the complaint and any possible resolution(s).
- 4. The Compliance Coordinator or his/her designee shall conduct such investigation of the complaint as may be appropriate to determine its validity. These rules contemplate

- informal but thorough investigations, affording all interested persons and their representatives, if any, an opportunity to submit evidence relevant to the complaint.
- 5. The Compliance Coordinator shall issue a written decision determining the validity of the complaint no later than thirty (30) days after its filing. The response will offer options for resolution of the complaint. The Union Parish Police Jury shall be advised of any decision or resolution regarding the complaint.
- 6. If the decision of the Compliance Coordinator does not resolve the issue, the complainant may appeal the decision of the Coordinator within fifteen (15) days after receipt of the response to the President or his or her designee.
- 7. The President or his or her designee shall meet with the complainant within 15 days after receipt of the appeal to discuss the complaint and any possible resolution. Within fifteen (15) days after the meeting the President or his or her designee will respond in writing, with a final resolution of the complaint.
- 8. The Section 504 Coordinator shall maintain the files and records or the resolution by the <u>President</u> relating to complaints filed hereunder.
- 9. The right of a person to prompt and equitable resolution of the complaint filed hereunder shall not be impaired by the person's pursuit of other remedies such as the filing of a Section 504 complaint with the Department of Housing and Urban Development or other Federal or State Agencies. Utilization of this grievance procedure is not a prerequisite to the pursuit of other remedies. Complaints may be forwarded for disposition to the:

## POLICY STATEMENT FOR COMMUNICATING INFORMATION TO PERSONS WITH SENSORY IMPAIRMENTS

### POLICY ON PROCEDURES FOR COMMUNICATING INFORMATION TO PERSONS WITH SENSORY IMPAIRMENTS

The Union Parish Police Jury will take such steps as are necessary to ensure that qualified handicapped persons, including those with impaired sensory skills, receive effective notice. All aids needed to provide this notice, e.g., sign-language interpreters, readers, etc., are provided without cost to the person being served.

#### **FOR PERSONS WITH HEARING IMPAIRMENTS**

1. Qualified sign-language interpreter

For persons who are hearing-impaired and who use sign-language as their primary means of communication, the following procedure has been developed and resources identified for obtaining the services of a qualified sign-language interpreter to communicate both verbal and written information:

The Union Parish Police Jury will provide qualified sign language interpreters on an as needed basis. Such an interpreter will be used at job interviews, large meeting, explanations of policies and procedures, etc. A minimum advance notice for such use is seven days unless circumstances or conditions dictate lesser time. In that case, the minimum time will be that required to notify the organization furnishing the interpreter as well as the time required for that organization to act. When time permits the request is to be in writing. If request is made orally, written documentation must be prepared and placed in the appropriate file. The following person(s) is authorized to obtain an interpreter: Paula Strickland, Secretary/Treasurer.

## LANGUAGE ACCESS PLAN FOR LIMITED ENGLISH PROFICIENCY PERSONS

#### I. Introduction

Title VI of the Civil Rights Act of 1964, 42 U.S.C. 2000(d) and Executive Order 13166 require that recipients of federal funds take responsible steps to ensure meaningful access by persons with Limited English Proficiency (LEP Persons). The Union Parish Police Jury is a recipient of federal funds for a portion of its programs and, thus obligated to reduce language barriers that can preclude meaningful access by LEP persons to the

Parish's programs. The Parish has prepared this Language Access Plan (LAP), which defines the actions to be taken to ensure meaningful access to Parish services, programs and activities on the part of persons who have limited English proficiency.

In preparing this LAP, the Parish conducted a four-factor analysis, considering (1) the number of proportion of LEP persons eligible to be served or likely to be encountered by the Parish or its federally funded programs, (2) frequency with which LEP persons come into contact with Parish's program, (3) nature and importance of the program, activity, or service to people's lives, and (4) resources available and costs. The Parish will review and update, on an annual basis, this LAP to ensure continued responsiveness to community needs.

#### II. Description of Covered Programs

The Union Parish Police Jury participates in the following federal and state programs:

- A. Louisiana Community Development Block Grant Program (LCDBG)

  The LCDBG program is a federally funded (HUD) program which provides grants to units of local governments in non- entitlement areas for the development of viable communities by providing a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income. Grants are made to these communities for primary needs such as potable water, water for fire protection, sewer, streets, and economic development activities.
- B. Disaster Recovery Unit (DRU)
  HUD CDBG Disaster allocations dedicated to recovery from Hurricane Katrina,
  Rita, Gustav, Ike and Issac. These funds have and continue to be allocated to
  housing, infrastructure, economic development and planning programs for recovery
  in the storm impacted areas.
- C. Local Government Assistance Program (LGAP) LGAP funds are used to assist units of local governments for needed infrastructure and long-term capital improvements in rural areas. The LGAP Program is designed to fill the gaps where there are no federal or state funds available to assist a unit of local government with an identified high priority need. Priority is given to those projects which identify and resolve basic human health and safety needs.
- D. Community Water Enrichment Fund (CWEF)

  The purpose of the CWEF program is to assist units of local governments with funding for needed infrastructure and long-term capital improvements for potable water projects in rural areas. The CWEF program is designed to fill the gaps where there are no federal or other state funds available to assist a unit of local government with an identified high priority need for potable water improvements. Priority is given to those projects which identify and resolve basic human health and safety needs.

#### III. Four- Factor Analysis

The following four-factor analysis will serve as the guide for determining which, if any, language assistance measures the Parish will undertake to provide access to the covered program for LEP process. Additionally, all future CDBG fund recipients will be required to use the same fur-factor analysis prior to the release of funds.

A. Number of proportions of LEP persons eligible to be served or likely to be encountered by the Parish or its federally funded programs. Per the 2017 5 Year American Community Survey Union's population 5 years and older (table S1601) is 90.06% of Union's population speaks only English and no other ethnicity has a sizable limited English proficiency.

#### SECTION 2 ENGINEERING SERVICES

All responses to the Request for Qualification Statements will be evaluated according to the following criteria and corresponding rating system. The respondents will be evaluated on the basis of written materials. Sufficient information must be included in the submittal to ensure the correct rating. Incomplete or incorrect information may result in a lower evaluation.

Administrative Screening: All Qualification Statements will be reviewed by the evaluation team to determine compliance with administrative and mandatory requirements as specified in the RFQ. Qualification Statements found not to be compliant will be rejected from further consideration. The evaluation team will determine the respondent most advantageous to the Union Parish Police Jury applying the evaluation factors set forth in the RFQ.
