SPECIAL MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana September 27th, 2021

The Union Parish Police Jury met this date in special session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan and Brenda Abercrombie. Absent: John Watley. Also present was Judith Hampton, Assistant District Attorney. The President called the meeting to order and welcomed all visitors. Mr. Bridges offered the invocation and Mr. Nyegaard led the group in the Pledge of Allegiance.

President Buckley welcomed the visitors in the audience and asked if anyone in the audience would like to register for public comment. The public was given the opportunity to comment on any item shown on the agenda.

Motion by Mr. Nolan, seconded by Mr. Bridges and declared adopted by unanimous roll call vote of the Jury to approve the agenda as written.

Recommendations from the Finance Committee:

Mr. Bridges reported that the Finance Committee met with Enterprise Fleet Management regarding purchasing vehicles and replacing the old vehicles that we currently have. Extensive research has been done and no negative feedback has been received. The Secretary/Treasurer reported that Mrs. Hampton has reviewed the contract information and all paperwork is in order. Motion Mr. Bridges, seconded by Mrs. Abercrombie to enter into an agreement with Enterprise Fleet Management to purchase new vehicles. Motion carried unanimously.

Motion Mr. Nolan, seconded by Mr. Ramsey to authorize the President to execute all necessary documents relating to the Enterprise agreements. Motion carried unanimously.

Recommendations from the Personnel Committee:

Mr. Ramsey reported that the Personnel Committee met on Thursday, September 23rd @ 6:00 PM and interviewed Scottie Shreve for the Public Works Director position. The position was advertised in the official journal on July 22, July 29, August 5 and August 12. Mr. Shreve expressed an interest and after meeting with him the position was offered to him pending approval by the full jury. Mr. Shreve holds a Landfill Class A Operator License. Mr. Shreve's primary focus will be the Landfill. He will also be over roads and manage scheduling and planning. Mr. Shreve's salary will be reevaluated in twelve months. Motion Mr. Ramsey, seconded by Mr. Bridges to hire Scottie Shreve for the Public Works Director position at a yearly rate of \$90,000; Mr. Shreve will start on October 18, 2021. Motion carried unanimously.

In accordance with Ordinance 549, time for public comment was given. No comments were made.

There being no further business to come before the Jury, the President declared the meeting adjourned upon motion by Mr. Nolan, seconded by Mr. Ramsey on this the 27th day of September, 2021.
