# REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana February 1st, 2022

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan and Brenda Abercrombie. Absent: John Watley. Also present was Judith Hampton, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Bridges offered the invocation and Mr. Buckley led the group in the Pledge of Allegiance to the Flag.

President Abercrombie welcomed everyone to the meeting. President Abercrombie announced the addition of two new members to the PEMAC Committee (Parish Emergency Management Advisory Committee). The two new additions are Ashley Rhodes from Marion and JR Horton from Bernice. President Abercrombie also announced the appointment of Burt Green as Union Parish Homeland Security Deputy Director.

President Abercrombie asked if anyone in the audience would like to register for public comment. At this time the public was given the opportunity to comment on any item shown on the agenda.

Motion Mr. Bridges, seconded by Mr. Buckley and declared adopted by unanimous vote of the Jury to approve the agenda as written.

Motion Mr. Bridges, seconded by Mr. Buckley to adopt the minutes of the January 4<sup>th</sup>, 2022 regular meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report for the month of January and explained to the jurors that the report reflects what has been budgeted for the year compared to what has been spent.

The Secretary/Treasurer reported that most of the Ad Valorem Tax has been collected for the year 2022. The parish receives tax revenue, money from timber/oil and gas severance tax, various fees for permits, money from the State's Parish Transportation Fund, rental payments, State Revenue Sharing and various taxes.

The Secretary/Treasurer highlighted the Sales Tax Collection, Detention Center Fund and Litter Court Fund. The Secretary/Treasurer commended Constable Scotty Aulds for his hard work on the Litter Court.

Motion Mr. Pilgreen, seconded by Mr. Moses to adopt the Revenue and Expenditures Report for the month of January. Motion carried unanimously.

Motion Mr. Buckley, seconded by Mr. Bridges to contribute \$5,000 to the American Crappie Masters National Fishing Tournament; the jury will be contributing with the Town of Farmerville, Union Parish Chamber of Commerce and Union Parish Tourist Commission. Motion carried unanimously.

Motion Mr. Buckley, seconded by Mr. Bridges to re-appoint Joanie Bryan and L.W. Nolan to the Rocky Branch/Crossroads Fire District for a two-year term beginning January 1, 2022 and ending December 31st 2023. Motion carried unanimously.

Jeff Toms, Regional Administrator Office of Public Health Region 8, is requesting a millage for the Union Parish Health Unit. The Secretary/Treasurer reported that in October 2015 the 1.70 millage renewal failed. That millage was used strictly for the operation of the Health Unit. As of today, the Health Unit has a fund balance of \$77,070 and has \$475,966.74 invested with LAMP (Louisiana Asset Management Pool). Motion Mr. Buckley, seconded by Mr. Bridges to authorize the Secretary/Treasurer to move forward with contacting Foley and Judell to prepare a tax proposition for one millage. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Nyegaard to approve the Town of Marion's request for two loads of cold mix with the town paying for the cost of the materials. Motion carried unanimously.

Motion Mr. Moses, seconded by Mr. Nyegaard to approve the use of the Courthouse parking lot by the Jaycees on Saturday, February 5<sup>th</sup> for the annual Mardi Gras festivities. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Nolan to contribute \$250 to Keep Union Beautiful for supplies to combat litter in the parish. Motion carried unanimously.

Two RFP's were received for Project Management Services for the American Rescue Plan Act Funds. RFP's were received from (1) Frye Magee and (2) Laura Hart. The scoring committee met on January 31<sup>st</sup> and evaluated all proposals. Laura Hart scored the highest. The scoring committee recommends that Laura Hart be awarded the Project Management Contract and authorize the President to execute a Notice of Award and any other necessary documents.

Motion Mr. Bridges, seconded by Mr. Ramsey to change the Trash Guys in-parish dumping fees from \$0.00 to \$19.03 a ton; out-of-parish tipping fees will be reduced to \$27.00 effective March 1, 2022. Motion carried unanimously.
