**Motion Mr. Ramsey, seconded by Mr. Bridges to recommend to the full jury to hire Richard Wheelington (Road Department) for full time employment effective April 11, 2022. He is now eligible for all police jury benefits including retirement, insurance, vacation, sick leave and holiday pay. Motion carried unanimously.**

**Motion Mr. Ramsey, seconded by Mr. Bridges to recommend to the full jury to hire Gregory "James" Hand (Landfill) for full time employment effective April 11, 2022. He is now eligible for all police jury benefits including retirement, insurance, vacation, sick leave and holiday pay. Motion carried unanimously.**

**Motion Mr. Ramsey, seconded by Mr. Bridges to recommend to the full jury to hire Charles D. Smith (Landfill) for full time employment effective April 11, 2022. He is now**

**eligible for all police jury benefits including retirement, insurance, vacation, sick leave and holiday pay. Motion carried unanimously.**
