

**EQUIPMENT COMMITTEE

Motion Mr. Buckley, seconded by Mr. Pilgreen and declared adopted by unanimous roll call vote of the Committee to approve the agenda as written.

Motion Mr. Moses, seconded by Mr. Pilgreen and declared adopted by unanimous vote to approve the minutes of the February 22nd, 2022 meeting. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Moses to recommend to the full jury to authorize the Secretary/Treasurer to advertise for bids for a sheepfoot roller to be used by the Road Department. Motion carried unanimously.

Motion Mr. Buckley, seconded by Mr. Pilgreen to recommend to the full jury that the jury apply for the Local Government Assistance Program (LGAP) grant through the State and authorize the President and/or Secretary/Treasurer to execute all necessary documents. Any monies received will be used to purchase a tractor and a side boom mower. Any monies previously allocated for a Caterpillar 926M Front End Loader will be utilized for this. Motion carried unanimously.

Motion Mr. Moses, seconded by Mr. Pilgreen to recommend to the full jury to declare surplus property at the Road, Landfill, Detention Center, Annex and Homeland Security Departments. Surplus property will be auctioned off through an auction with the Union Parish Sheriff's Department and Gov Deals.
