### REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana May 3<sup>rd</sup>, 2022

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan, Brenda Abercrombie and Andrew Ford, Jr. Absent: None. Also present was James Buckley, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Nolan offered the invocation and Mr. Pilgreen led the group in the Pledge of Allegiance to the Flag.

Pursuant to Public Notice published in *The Banner*, a weekly newspaper published in Farmerville, Union Parish, Louisiana and the Official Journal of the Union Parish Police Jury on March 31, April 7, April 14 and April 28, 2022, Public Hearing was being held by the Union Parish Police Jury at the Police Jury Meeting Room, Courthouse Annex, 303 East Water Street, Farmerville, Louisiana for the purpose of considering whether or not certain road listed in said Public Notice should be deleted from the Union Parish Road System.

**NOW, THEREFORE, BE IT ORDAINED**, by the Police Jury of Union Parish, Louisiana, convened in Regular Session this 3<sup>rd</sup> day of May, 2022 that the following Ordinance be and the same is hereby adopted:

### **SECTION 1**

Approximately 600 feet of Rodeo Drive is found to be no longer needed for public purposes and is hereby deleted and removed from the Union Parish Road System.

Motion Mr. Moses, seconded by Mr. Nyegaard to allow the Farmerville Jaycees the use of the Courthouse Square and parking lot on Friday July 29<sup>th</sup> and Saturday July 30<sup>th</sup> for the 59<sup>th</sup> Annual Louisiana Watermelon Festival. Motion carried unanimously.

Motion Mr. Ramsey, seconded by Mr. Moses to approve travel for the Registrar of Voters and the Deputy Registrar of Voters to attend the Annual Elections Academy to be held in Baton Rouge on June 23<sup>rd</sup>, 2022. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Buckley to authorize the Secretary/Treasurer to advertise for the abandonment of Lifford Road in its entirety and a portion of Phillips Road from the Union Parish Police Jury Road System. Motion carried unanimously.

Motion Mr. Bridges, seconded by Mr. Nolan to approve travel for the JP/Constables/Deputy Constables to attend the annual seminar in Baton Rouge on June 22 and June 23<sup>rd</sup>, 2022. Motion carried unanimously.

Motion Mr. Moses, seconded by Mr. Ford to approve travel for the HUD Director to attend the Louisiana Housing Council Annual Legislative Conference in Baton Rouge on May 24<sup>th</sup>, 2022. Motion carried unanimously.

Laura Hartt, ARPA Grants Manager, addressed the jury regarding the funds that the D'Arbonne Water System received through the American Rescue Plan Act. D'Arbonne Water System is out of compliance with the Federal Procurement Guidelines. Mrs. Hartt stated that in order to protect the interests of the jury a CEA (cooperative endeavor agreement) would need to be entered into that states the water system will be responsible for repayment of any grant monies in the event the costs are disallowed by the US Treasury. Mrs. Hartt further stated that James Buckley, Assistant District Attorney, has reviewed the document and concurs that this is what is needed. Motion Mr. Ford, seconded by Mr. Bridges to enter into a Cooperative Endeavor Agreement between Union Parish Police Jury and D'Arbonne Water System. Motion carried with the following vote:

# Recommendations from the Ambulance Steering Committee:

The Secretary/Treasurer reported that the Union Parish Ambulance Steering Committee met earlier. Request for Proposals were solicited for an Ambulance service in Union Parish. Those proposals were opened on April 19<sup>th</sup> and presentations were made by Pafford Ambulance Service and Acadian Ambulance Service. The Request for Proposals were scored earlier today by the following members: Mayor Danny Smith (TOM), Cade Nolan (TOF), Ben Bridges (UPPJ), Beth Jones (RMMC), Mayor Mildred Ferguson (TOB), Mayor Reggie Skains (Village of Downsville), Curtis Moses (UPPJ), Connie Ginn (UGH), Brenda Abercrombie (UPPJ), Beth Green (Rocky Branch Crossroads Fire District and Sheriff Dusty Gates (UPSO). Pafford Ambulance received a total score of 1373 and Acadian Ambulance received a total score of 1044. Motion Mr. Bridges, seconded by Mr. Buckley to accept the proposal from Pafford Ambulance Service. Motion carried unanimously.

### Recommendations from the Landfill Committee:

Motion Mr. Bridges, seconded by Mr. Pilgreen to authorize Turner Specialty Services, Inc. to clean the seven (7) manholes in an amount up to \$12,000 and if necessary, video for an additional \$4,500 with the total amount for the manhole cleaning not to exceed \$16,500. Motion carried unanimously.

In accordance with Ordinance 549, time for public comment was given. Bernie Nolan addressed the jury concerning a fund raiser for the Union Humane Society.

TC Dupree addressed the jury concerning a need for a contract with Pafford Ambulance Service. Mr. Dupree stated that the only way to hold any ambulance service accountable is to have a contract.

Lynn Ramsey addressed the jury regarding a fund raiser for Sherri Cooper Taylor. It will be at the D'Arbonne Range Rider Arena on May 21<sup>st</sup>, 2022.

There being no further business to come before the Jury, the President declared the meeting adjourned upon motion by Mr. Buckley, seconded by Mr. Nolan on this the 3<sup>rd</sup> day of May, 2022.
