

**LANDFILL COMMITTEE  
MINUTES OF MEETING  
October 11<sup>th</sup>, 2022  
4:00 P.M.**

Present: Ben Bridges, DeWayne Ramsey, Nathan Pilgreen and L.W. Nolan. Absent: None.  
Also present: Johnny Buckley, Brenda Abercrombie, Ceis Nyegaard, Bryon Avery, Danielle Harkins, Bernie Nolan, Lynn Ramsey, Milas Davidson and Justin Echols.

Mr. Bridges called the meeting to order. Mr. Buckley led the group in prayer.

**Motion Mr. Pilgreen, seconded by Mr. Nolan and declared adopted by unanimous vote to approve the agenda as written.**

**Motion Mr. Pilgreen, seconded by Mr. Nolan to approve the minutes of the September 6<sup>th</sup> meeting (October 4<sup>th</sup> meeting cancelled due to lack of a quorum). Motion carried unanimously.**

A brief discussion was held regarding the bids received for the Front Load Garbage Trucks. The following two bids were received:

- RiverCity Hydraulics, Inc.      \$645,694.00
- McNeilus                              \$668,166.00

McNeilus specified a one-year warranty. McNeilus also submitted a proposal with a better built bed. **Motion Mr. Pilgreen, seconded by Mr. Nolan to recommend to the full jury to accept the bid from McNeilus in the amount of \$668,166 for two (2) Front Load Garbage Trucks based on the specs and warranty. Motion carried unanimously.**

A brief discussion was held regarding the bids received for the Front Load Dumpsters. The Secretary/Treasurer reported that the following bids were received:

- Technology International, Inc.      Bid received late. Did not open.
- Wastequip                              \$126,685 for 100 dumpsters
- Box Gang Manufacturing, LLC      \$127,500 for 100 dumpsters
- Roll Offs USA                          \$130,700 for 100 dumpsters

The Secretary/Treasurer was asked to contact Wastequip and inquire about a time frame for the dumpster delivery. The garbage trucks won't be delivered until July 2023 and the dumpsters do not need to be sitting at the Landfill for months. **Motion Mr. Pilgreen, seconded by Mr. Nolan to recommend to the full jury to accept the lowest bid from Wastequip in the amount of \$126,685 for one hundred (100) Front Load Dumpsters and request a delivery date of June 2023. Motion carried unanimously.**

**Motion Mr. Pilgreen, seconded by Mr. Nolan to recommend to the full jury to authorize the Secretary/Treasurer to attend the Louisiana Solid Waste Association Workshop to be held in Lake Charles on October 25 and October 26. Motion carried unanimously.**

**Motion Mr. Nolan, seconded by Mr. Pilgreen to recommend to the full jury to authorize the Secretary/Treasurer to travel to Baton Rouge to test for the Class A Operator Exam on October 28<sup>th</sup>. Motion carried unanimously.**

**There being no more business to come before the committee, Mr. Bridges declared the meeting adjourned upon motion by Mr. Pilgreen and duly seconded by Mr. Nolan on this the 11<sup>th</sup> day of October, 2022.**
