REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana March 7th, 2023

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, DeWayne Ramsey, Johnny Buckley, Ben Bridges, Ceis Nyegaard, L.W. Nolan, Brenda Abercrombie and Andrew Ford, Jr. Absent: None. Also present was James Buckley, Assistant District Attorney. The President called the session to order and welcomed all guests. Mr. Buckley offered the invocation and President Abercrombie led the group in the Pledge of Allegiance to the Flag.

President Abercrombie welcomed everyone to the meeting. President Abercrombie asked if anyone in the audience would like to register for public comment. At this time the public was given the opportunity to comment on any item shown on the agenda.

Mr. Pilgreen addressed the jury concerning the recent death of Mike Thurston. Mike Thurston worked for the road department for 25 and a half years. Mr. Thurston recently retired in December from the Union Parish Road Department. Mr. Pilgreen asked that the family be remembered.

Motion Mr. Buckley, seconded by Mr. Bridges and declared adopted by unanimous vote of the Jury to approve the agenda as written.

Motion Mr. Ramsey, seconded by Mr. Nolan to adopt the minutes of the February 7th, 2023 regular meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report for the month of February and explained to the jurors that the report reflects what has been budgeted for the year compared to what has been spent.

The Secretary/Treasurer highlighted the General Fund, Road Fund, Sales Tax Collection, and Detention Center Fund. The Secretary/Treasurer also reported on the recent Union/Lincoln Sales Tax Commission meeting and how much each municipality/entity receives in sales tax for the parish.

Motion Mr. Nolan, seconded by Mr. Bridges to adopt the Revenue and Expenditures Report for the month of February. Motion carried unanimously.

The following resolution was offered by Mr. Nolan and duly seconded by Mr. Ford:

UP RESOLUTION 2023-03

A resolution approving the issuance, sale and delivery of not exceeding Twenty-Eight Million Dollars (\$28,000,000) of Hospital Revenue Bonds, in one or more series, of Wards 3, 4 and 10 Hospital Service District of the Parish of Union, State of Louisiana, and providing for other matters in connection therewith.

WHEREAS, Wards 3, 4 and 10 Hospital Service District of the Parish of Union, State of Louisiana (the "District"), a public corporation and political subdivision of the State of Louisiana, currently owns and operates a hospital and related health care facilities in Union Parish, Louisiana, known as Reeves Memorial Medical Center (the "Existing Hospital"); and

WHEREAS, the Board of Commissioners (the "Board") of the District, by resolution adopted on November 10, 2022, has authorized the issuance of not exceeding \$28,000,000 of Hospital Revenue Bonds (the "Bonds"), for the purpose (i) acquiring, constructing and equipping a new hospital facility (the "Project"), (ii) funding certain reserve funds, and (iii) paying the costs of issuing the Bonds; and

WHEREAS, the Existing Hospital and the Project, together with any all properties of every nature owned by the District and used or useful in the operations thereof, shall be referred to herein as the "Hospital"; and

WHEREAS, the Bonds shall be payable from the dedication and pledge of the income, revenues and receipts derived or to be derived by the District from an irrevocable pledge and dedication of the income and revenues derived from the operation of the Hospital, after payment therefrom of the reasonable and necessary expenses of operating and maintaining the Hospital, as now existing or as may be hereafter improved, extended or supplemented from any source whatsoever, and may be further secured by a mortgage granted on the Hospital; and

WHEREAS, the Board held a public hearing on January 26, 2023, with respect to the issuance of the Bonds at which public hearing no petitions objecting to the issuance of the Bonds were presented; and

WHEREAS, it is now the desire of the Police Jury of the Parish of Union, State of Louisiana to approve the issuance of the Bonds:

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Union, State of Louisiana (the "Police Jury"), acting as the governing authority of the Parish of Union, State of Louisiana (the "Parish"), that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of the District, this Police Jury hereby approves the issuance of the Bonds of the District. The Bonds are to be issued under the authority and for the purposes stated in the preamble hereto. The Bonds shall bear interest at a rate or rates not to exceed nine percent (9%) per annum, and shall mature over a period of not exceeding thirty (30) years from the date of issuance.

SECTION 2. Neither the Parish nor this Police Jury shall be liable in any manner for the payment of the Bonds.

AN ORDINANCE TO AUTHORIZE AN ACT OF SALE BY THE PARISH OF UNION TO SELL ADJUDICATED PROPERTY DESCRIBED AS: PARCEL NO. 3011044475: A CERTAIN LOT OR PARCEL OF LAND LOCATED IN THE TOWN OF FARMERVILLE, UNION PARISH, LA DESCRIBED AS FOLLOWS: BEGINNING AT THE NE CORNER OF THE PROPERTY OF A.L. BUCKLEY WHICH WAS PURCHASED BY C.A. BUCKLEY FROM D.E. BAGWELL, AS DESCRIBED, IN DEED BOOK 101, PAGE 318 OF THE UNION PARISH RECORDS AND AT THE POINT WHERE THE ROAD LEADING FROM THE COX FERRY ROAD TO THE HOME OF DR. C.D. WHEREAS, the immovable property described below was adjudicated to the Parish of Union on June 5, 2016 for nonpayment of taxes; and

WHEREAS, the three (3) year period for redemption, provided by Art. 7, §25 of the Louisiana Constitution has elapsed and established by Parish Ordinance No: 908 and the owner of record has failed to redeem the adjudicated property; and

WHEREAS, LA R.S. 47: 2202 *et seq*. provides that the Parish may sell adjudicated property in accordance with law after the expiration of the period for redemption; and

WHEREAS, the Parish of Union has declared the property described below surplus and not needed for a public purpose and to dispose of said property in accordance with LA R.S. 47:2202, et seq.; and

WHEREAS, in accordance with L.A. R.S. 47:2202 the Parish of Union has set a minimum purchase price in the amount of \$885.71 and

WHEREAS, the Parish of Union has received a written offer to purchase said property from James E. Franklin for the consideration of \$885.71, at the time of sale and has been accepted by the Union Parish Police Jury; and

WHEREAS, the property described herein below was scheduled for public auction on March 2, 2023 at 10:00 a.m.

Legal Description: A certain lot or parcel of land located in the Town of Farmerville, Union Parish, LA described as follows: Beginning at the NE corner of the property of A.L. Bagwell, as described, in Deed Book 101, page 318 of the Union Parish Records) and at the point where the road leading from the Cox ferry Road to the home of Dr. C. D. - 2) The sale shall be on a form approved by the Parish Attorney and that the sales price is paid by certified funds at the time of the sale.

- 3) The sale shall include a reservation of all mineral rights to the Parish, but shall convey all surface rights.
- 4) The following shall be completed prior to closing of sale:
 - a. E&P Consulting Services, LLC shall certify in writing to the Parish Attorney that they have examined the mortgage records, conveyance records, probate and civil suit records of the Parish of Union and that attached to this certification will be a written list of names and last known addresses of all owners, mortgagees, and any other person who may have a vested or contingent interest in the property, or who has filed a request for notice as provided in the former provisions LS-R.S. 33:4720.17(B), as indicated in those records.
 - b. E&P Consulting Services, LLC will provide notice to those persons identified in accordance with LS-R.S. 47:2201 *et. seq.* Proof of said notice will be filed in the conveyance records of Union Parish immediately after the Act of Sale.
 - c. At the time of closing, E&P Consulting Services, LLC will certify in writing to Parish Attorney and Clerk of Court that the number of days mandated by LS-R.S. 47:2201 *et. seq.* has elapsed since the above required notice was made or attempted and that the property has not been redeemed by the payment of the taxes owed.

Recommendations from the Airport Committee:

Mr. Nolan reported that the Airport Committee met earlier and has two recommendations.

Motion Mr. Nolan, seconded by Mr. Ramsey to charge \$500 per year for a hangar lease at the Union Parish Airport. This will affect new leases beginning March 1st, 2023. Motion carried unanimously.

Motion Mr. Nolan, seconded by Mr. Bridges to enter into a lease agreement with Mark Branch (existing Hangar 5) and Chad Robinson (new build) at the Union Parish Airport for the sum of \$500 per year and authorize the President to execute each lease agreement. Motion carried unanimously.

Recommendations from the Landfill Committee:

Mr. Bridges reported that the Landfill Committee met earlier and discussed several items, but the committee only has one recommendation.

Motion Mr. Bridges, seconded by Mr. Nolan to authorize the Secretary/Treasurer to advertise for an off-road truck once the specs have been provided by the Public Works Director. Motion carried unanimously.

Mr. Bridges reported that bids were received at 9AM today for a Landfill Compactor. Two bids were received for the compactor: Louisiana Cat submitted a bid in the amount of \$1,540,113.55 and Lyle Machinery submitted a bid in the amount of \$1,179,320.00. Mr. Bridges stated that the machines are different brands. Before a decision can be made, Mr. Bridges is requesting that the Public Works Director and the Landfill Superintendent inspect the Tana Landfill Compactor to see how it compares to the Caterpillar.

Recommendations from the Road Committee:

Mr. Nyegaard reported that the Road Committee met earlier and have several recommendations.

Motion Mr. Nyegaard, seconded by Mr. Bridges to hire Laura Hartt to assist with Project Management Services for the Scott's Hideaway Hazard Mitigation Project. Motion carried unanimously.

Motion Mr. Nyegaard, seconded by Mr. Ford to enter into an agreement with Hiperweb Software in the amount of \$12,700 for the first year and \$6,700 for every year thereafter and authorize the Secretary/Treasurer to execute the agreement. Motion carried unanimously.

Motion Mr. Nyegaard, seconded by Mr. Moses to assist with work in the Village of Junction City (302 South Pecan Street, 303 South Main & 6^{th} Street and 411 East 6^{th} Street) with the Village of Junction City paying for the cost of materials. Work will be performed as time allows. Motion carried unanimously.

ORDINANCE # 949

AN ORDINANCE SETTING THE SPEED LIMIT OF 35 MILES PER HOUR ON SCOTTS HIDEAWAY ROAD IN ITS ENTIRETY AND SETTING PENALTIES FOR VIOLATIONS.

SECTION I: BE IT ORDAINED by the Police Jury of Union Parish that a maximum speed limit for any truck, car, motorcycle or any other equipment traveling on **Scotts Hideaway Road** in its entirety, shall not exceed 35 miles per hour.

SECTION II: BE IT FURTHER ORDAINED by the Police Jury of Union Parish, State of Louisiana, that any person, firm or corporation violating any provisions of this ordinance, upon conviction, shall not exceed the maximum fine for speeding upon a state highway plus court cost.

SECTION III: BE IT FURTHER ORDAINED that if any section, sentence, clause or words of this ordinance shall be held invalid by any court of final jurisdiction, the same shall not affect the validity of any other section.

SECTION IV: BE IT FURTHER ORDAINED that ordinance or parts of ordinance in conflict herewith be and the same are hereby repealed.

Motion Mr. Buckley, seconded by Mr. Ramsey to waive the retirement probationary period for the Public Works Director, Tommy Durrett. His retirement contributions shall begin on Wednesday, March 8th. This will not affect any other benefits such as accruing vacation/sick time or holiday pay. Motion carried unanimously.

Recommendations from the Finance Committee:

The Finance Committee met earlier and has four recommendations.

Motion Mr. Ramsey, seconded by Mr. Moses to purchase two (2) John Deere 5060E Tractors and two (2) John Deere 520M Loaders in the amount of \$46,509.31 each from Goldman Equipment, LLC. Both of these items are on state contract. Funds to purchase will come out of the ARPA funds pending a committee meeting. Motion carried unanimously.

Motion Mr. Ramsey, seconded by Mr. Bridges to authorize the Secretary/Treasurer to advertise for the purchase of an Oil Tanker Truck. Motion carried unanimously.

UP RESOLUTION 2023-04

A resolution of intention of the Police Jury of the Parish of Union, State of Louisiana, to create a Sewerage District in Union Parish, Louisiana, ordering and directing the President of said Police Jury to give notice of the proposed creation and proposed boundaries of said Sewerage District, and providing for the hearing of any and all objections to the creation and boundaries of said Sewage District.

WHEREAS, the Police Jury of the Parish of Union, State of Louisiana (the "Police Jury"), intends to create a Sewerage District in Union Parish; and

WHEREAS, Louisiana Revised Statutes 33:3881, authorizes Police Juries (parish governing authorities) to create Sewerage Districts composed of territory outside the corporate limits of municipalities; and

WHEREAS, the governing authority of the District requested that a Sewerage District be created; and

WHEREAS, pursuant to the Act, it is now the desire of this Police Jury to create a Sewerage District;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Union, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of the Act and other constitutional and statutory authority, it is the intention of this Police Jury to create a Sewerage District in District 8, Union Parish, Louisiana, such that the following described areas are added to the boundaries of the District:

The point of beginning being the intersection of Pinewood Road and State Route 143; thence, westerly on Pinewood Road to Arkansas Road; thence, northerly on Arkansas Road to an un-named rural road; thence, southwesterly on an un-named rural road to Buffalo Hole Road; thence, westerly on Buffalo Hole Road to Lonnie Branch; thence, southerly on Lonnie Branch to Bayou de Loutre; thence, southeasterly along Bayou de Loutre to Ferry Road; thence, southwesterly on Ferry Road to Crossroads Loop; thence, westerly on Crossroads Loop to West Port Union Road; thence, westerly on West Port Union Road to Hodge Road; thence, southwesterly on Hodge Road to Bayou D'arbonne; thence, westerly along Bayou D'arbonne to Francis Creek; thence, southwesterly along Francis Creek to Ruggs Bluff Road; thence, southeasterly on Ruggs Bluff Road to Highway 552; thence, westerly on Highway 552 to Prentice Pardue Road; thence, southerly on Prentice Pardue Road to a powerline; thence, southwesterly along the powerline to Mars Hill Road; thence, southerly on Mars Hill Road to Goldsmith Road; thence, southerly on Goldsmith Road to Old New Orleans Road; thence easterly on Old New Orleans Road to Wilhite Cemetery Road; thence, easterly on Wilhite Cemetery Road to Highway 552; thence, southwesterly on Highway 552 to the southern boundary of Union Parish; thence, northeasterly along the southern boundary of Union Parish to an extension of River Road; thence, southwesterly on River Road to Pruitt Road; thence, westerly on Pruitt Road to a powerline; thence, northwesterly along the powerline to Ouachita City Road; thence, northwesterly on Ouachita City Road to Cook Cemetery Road; thence, westerly on Cook Cemetery Road to its intersection with Henry Cook Road; thence, southerly on Henry Cook Road to Ouachita City Road; thence, westerly on Ouachita City Road to State Route 143; thence, northerly on State Route 143 back to the point of beginning.

SECTION 2. This Police Jury shall meet in open and public session at the Police Jury Meeting Room of the Courthouse Annex, 303 E.
