REGULAR MEETING UNION PARISH POLICE JURY

Farmerville, Louisiana January 7th, 2025

The Union Parish Police Jury met this date in regular session in the Police Jury meeting room, Courthouse Annex, Farmerville, Louisiana with the following present: Curtis Moses, Nathan Pilgreen, Michael Holley, Glenn Hutto, Russell Wade, Jeremy Hobbs, Brenda Abercrombie and Andrew Ford, Jr. Absent: Ben Bridges. Also absent was James Buckley, Assistant District Attorney. The President called the session to order and welcomed all guests. President Hutto offered the invocation and Mr. Ford led the group in the Pledge of Allegiance to the Flag.

President Hutto welcomed everyone to the meeting. President Hutto asked if anyone in the audience would like to register for public comment. At this time the public was given the opportunity to comment on any item shown on the agenda.

Nathan Pilgreen recognized Matt Ford, Union Parish Homeland Security Director, for the swift response during the recent tornado. Mr. Ford passed out water and tarps. Mr. Pilgreen also recognized the area fire departments who also assisted in the cleanup.

President Hutto recognized a special guest in the audience. Senator Stewart Cathey addressed the jury with a brief legislative update. Senator Cathey also addressed the jury regarding the following:

- A loss of approximately 7 to 8 million dollars for water improvements to Downsville
- State income tax rate; area state income tax rates
- How inventory tax works
- Increased exemption for seniors
- Area states charge annual property tax on vehicles
- What does the parish need in regards to equipment

Matt Ford, Union Parish Homeland Security Director, addressed the jury regarding the severe weather that occurred on January 5th, 2025. Mr. Ford provided the following tornado details:

- Rating EF2
- Peak Winds 132 MPH
- Path Length 4.63 miles
- Path Width 650 yards

Mr. Ford also recognized the following agencies that assisted in the clean-up: NE Union Fire Department, Truxno Fire Department, Sadie Tiger Bend Fire Department, Spencer/West Sterlington Fire Department, Huttig Fire Department, Pafford Ambulance Service, Claiborne Electric, Union Parish Police Jury Road Department and Dean Baptist Church. Mr. Ford thanked Nathan and Jodi Pilgreen for also assisting with the clean-up efforts.

Motion Mr. Pilgreen, seconded by Mr. Ford and declared adopted by unanimous vote of the Jury to approve the agenda as written.

Motion Mr. Wade, seconded by Mr. Ford to adopt the minutes of the December 3rd, 2024 regular meeting and December 30th, 2024 special meeting. Motion carried unanimously.

The Secretary/Treasurer presented the Budget to Actual Revenue and Expense report for the month of December to the Finance Committee earlier. Motion Mr. Wade, seconded by Mr. Holley to adopt the Revenue and Expenditures Report for the month of December. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Ford setting the regular monthly meetings of the Union Parish Police Jury to be held at the Courthouse Annex on the first (1st) Tuesday of every month at 6:00 p.m. Motion carried unanimously.

Motion Mr. Pilgreen, seconded by Mr. Wade to approve the 2025 holiday schedule as presented. Motion carried unanimously.

Motion Mr. Holley, seconded by Mr. Pilgreen to appoint Michael Holley as the jury representative to the North Delta Regional Planning and Development District, Inc. Motion carried unanimously.

Motion Mr. Moses, seconded by Mr. Ford to allow Union Christian Academy the use of the Courthouse Square on April 5th, 2025. Motion carried unanimously.

A resolution providing for canvassing the returns and declaring the results of the special election held in the Parish of Union, State of Louisiana, on Saturday, December 7, 2024, to authorize the renewal of special taxes therein.

BE IT RESOLVED by the Police Jury of the Parish of Union, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Union, State of Louisiana (the "Parish"), that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of Union, State of Louisiana, on Saturday, December 7, 2024 (the "Election"), to authorize the renewal of special taxes therein pursuant to the following propositions (the "Propositions"):

PROPOSITION NO. 1 OF 3 (TAX RENEWAL)

Shall the Parish of Union, State of Louisiana (the "Parish"), continue to levy a 5.13 mills tax on all property subject to taxation in the Parish (an estimated \$806,400 reasonably expected to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, both years inclusive, with the revenues therefrom to be used for the purpose of construction and improvement of public roads and bridges throughout Union Parish, Louisiana?

PROPOSITION NO. 2 OF 3 (TAX RENEWAL)

Shall the Parish of Union, State of Louisiana (the "Parish"), continue to levy a 6.15 mills tax on all property subject to taxation in the Parish (an estimated \$966,700 reasonably expected to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, both years inclusive, with the revenues therefrom to be used for the purpose of maintenance of public roads and bridges throughout Union Parish, Louisiana?

PROPOSITION NO. 3 OF 3 (TAX RENEWAL)

Shall the Parish of Union, State of Louisiana (the "Parish"), continue to levy a 2.40 mills tax on all property subject to taxation in the Parish (an estimated \$377,200 reasonably expected to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, both years inclusive, with the revenues therefrom to be used for the operation and maintenance of the Union Parish Public Library?

This Governing Authority does further proceed to examine and canvass the returns of the Election thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Election.

at said Election,

(i) there was a total of **925** votes cast **IN FAVOR OF** Proposition No. 1 and

a total of 1,454 votes cast AGAINST Proposition No. 1, resulting in a majority of

529 votes cast AGAINST Proposition No. 1;

(ii) there was a total of **914** votes cast **IN FAVOR OF** Proposition No. 2 and a total of **1,462** votes cast **AGAINST** Proposition No. 2, resulting in a majority of **548** votes cast **AGAINST** Proposition No. 2; and

(iii) there was a total of **1,230** votes cast **IN FAVOR OF** Proposition No. 3 and a total of **1,147** votes cast **AGAINST** Proposition No. 3, resulting in a majority of **83** votes cast **IN FAVOR OF** Proposition No. 3.

The Proposition No. 1 and Proposition No. 2 were therefore duly **DEFEATED** and Proposition No. 3 was therefore duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the Election.

SECTION 3. <u>Promulgation of Election Result.</u> The results of said election shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the election, as required by §18:1292 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 4. <u>Declaration</u>. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of the Election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in her office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Union, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

There was found by said count and canvass that (i) there was a total of **925** votes cast **IN FAVOR OF** Proposition No. 1 and a total of **1,454** votes cast **AGAINST** Proposition No. 1, as hereinabove set forth, and it was further found and determined that there was a majority of **529** votes cast **AGAINST** Proposition No. 1 as hereinabove set forth, (ii) there was a total of **914** votes cast **IN FAVOR OF** Proposition No. 2 and a total of **1,462** votes cast **AGAINST** Proposition No. 2, as hereinabove set forth, and it was further found and determined that there was a majority of **548** votes cast **AGAINST** Proposition No. 2 as hereinabove set forth and (iii) there was a total of **1,230** votes cast **IN FAVOR OF** Proposition No. 3 and a total of **1,147** votes cast **AGAINST** Proposition No. 3, as hereinabove set forth, and it was further found and determined that there was a majority of **83** votes cast **IN FAVOR OF** Proposition No. 3 as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that Proposition No. 1 and Proposition No. 2 as hereinabove set forth were duly **DEFEATED** and Proposition No. 3 as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the Parish on Saturday, December 7, 2024.
