

**ROAD COMMITTEE  
MINUTES OF MEETING  
August 5<sup>th</sup>, 2025  
4:45 P.M.**

Present: Mike Holley, Russell Wade, Nathan Pilgreen and Curtis Moses. Absent: None.  
Also present: Glenn Hutto, Ben Bridges, Brenda Abercrombie, Andrew Ford, Jr., Danielle Harkins and Linda Hammett.

Mr. Holley called the meeting to order. Mr. Pilgreen led the group in prayer.

Public Comment on agenda items – No comments were made.

**Motion Mr. Wade, seconded by Mr. Pilgreen and declared adopted by unanimous vote of the Committee to approve the agenda as written.**

**Motion Mr. Moses, seconded by Mr. Pilgreen to approve the minutes of the July 15<sup>th</sup>, 2025 meeting. Motion carried unanimously.**

A brief discussion was held regarding the Off-System Bridge Priority List. The Secretary/Treasurer recently attended a meeting at DOTD regarding the program. Union Parish Police Jury has \$1,005,531 available in the Off-System Bridge Program. DOTD will allow the jury to “bank” the funds to be used at a later date. **Motion Mr. Pilgreen, seconded by Mr. Moses to recommend to the full jury to roll forward the Off System Bridge money that was allocated by DOTD. Motion carried unanimously.**

A brief discussion was held regarding the preliminary subdivision approval for Cypress Cove Subdivision. Cypress Cove Subdivision is owned by Trey Towns. A preliminary plat and roadway plan per section 15.5-51 of Article IV Procedures for Subdivision Review and Approval has been inspected by Paul Riley. Mr. Riley is certifying that the plans and specs meet the Union Parish Police Jury requirements as specified in Union Parish Police Jury Ordinance 975. **Motion Mr. Wade, seconded by Mr. Moses to recommend to the full jury to approve the Preliminary Plat and Roadway Plan for Cypress Cove Subdivision. Motion carried unanimously.**

A discussion was held concerning the Priority lists for years 2026, 2027 and 2028. Paul Riley presented the following four (4) lists:

- Primary Hard Surface Roads
- Secondary Hard Surface Roads
- Overlay list
- Gravel Roads

**Motion Mr. Wade, seconded by Mr. Pilgreen to recommend to the full jury to approve the priority lists for 2026, 2027 and 2028 as presented to the Road Committee by Paul Riley. Motion carried unanimously.**

The Secretary/Treasurer gave a brief update on the DRA application for Camp Road and Dozier Road.  
**No action taken.**
